ORDINANCE NO. 2000-03-01

AN ORDINANCE OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS, DISANNEXING CERTAIN TERRITORY FROM THE CORPORATE LIMITS OF THE CITY PURSUANT TO V.T.C.A., LOCAL GOVERNMENT CODE SECTION 43.144; AMENDING THE CORPORATE LIMITS OF THE CITY TO COMPLY WITH THE SAID DISANNEXATION; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, Tracts 20, 20-9, 22, 22-9, 23, 23-9, and 31 of the Robert Skaggs Survey, Abstract No. 801, a copy of which is attached hereto and made a part hereof as Exhibit "A", were incorporated as part of the City of Weston in 1971. The combined territory of the said Tracts is more particularly described by metes and bounds, also included in Exhibit "A";

WHEREAS, said Tracts are contiguous and form a combined territory of at least ten (10) acres of land that contains fewer than one (1) occupied residence or business structure for every two (2) acres and fewer than three (3) occupied residences or businesses on any one (1) acre;

WHEREAS, a majority of the property owners of the said Tracts described in Exhibit "A" have requested in writing that these Tracts be disannexed from the City of Weston;

WHEREAS, the City Council of Weston believes that disannexation of the Tracts described in Exhibit "A" is in the general welfare of the City and the property owners of the said Tracts.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS.

Section 1. Disannexation of Area

Pursuant to V.T.C.A., Local Government Code Section 43.144, Tracts 20, 20-9, 22, 22-9, 23, 23-9, and 31 of the Robert Skaggs Survey, Abstract No. 801, as described in the attached Exhibit "A", are hereby disannexed from the corporate limits of the City.

Section 2. Corporate Limits Amended

The corporate limits of the City of Weston are hereby amended to comply with the disannexation described in this Ordinance.

Section 3. Authorization

The Mayor of Weston is hereby authorized and directed to implement this Ordinance immediately upon its effective date.


