ordinance no. <u>2000 - 09</u>-05

AN ORDINANCE OF THE CITY OF WESTON, TEXAS, DISANNEXING CERTAIN TERRITORY FROM THE CORPORATE LIMITS OF THE CITY PURSUANT TO V.T.C.A., LOCAL GOVERNMENT CODE, SECTION 43.144; AMENDING THE CORPORATE LIMITS OF THE CITY TO COMPLY WITH THE SAID DISANNEXATION; AND PROVIDING FOR AN EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, by an Ordinance adopted on March 2, 1972, the City of Weston annexed certain territory in the Roland area adjacent to County Roads 168, 201, and 203, and FM Highway 543. The annexed territory is more particularly described by metes and bounds in Field Notes contained in the said Ordinance adopted on March 2, 1972. A copy of the said Field Notes is attached hereto and made a part hereof as Exhibit "A";

WHEREAS, all of the properties within the subject annexed territory that are located South of a line drawn parallel to and 500 feet North of the North right-of-way lines of County Road 168, FM Highway 543, and County Road 203 are depicted as shaded areas on maps attached hereto and made a part hereof as Exhibit "B";

WHEREAS, the combined subject properties depicted in Exhibit "B" consist of at least ten (10) acres of land contiguous to the City and contain fewer than one (1) occupied residence or business structure for every two (2) acres and fewer than three (3) occupied residences or businesses on any one (1) acre;

WHEREAS, the Weston City Council believes that disannexation of the subject properties identified in Exhibit "B" is in the general welfare of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS.

Section 1. Disannexation of Area

Pursuant to V.T.C.A., Local Government Code, Section 43.144, all of the subject properties depicted as shaded areas in the attached Exhibit "B" are hereby disannexed from the corporate limits of the City.

Section 2. Corporate Limits Amended

The corporate limits of the City of Weston are hereby amended to comply with the disannexation described in this Ordinance.

Section 3. Authorization

The Mayor of Weston is hereby authorized and directed to implement this Ordinance immediately upon its adoption.

Section 4. Effective Date

This Ordinance shall be effective on the date of its adoption.

FIELD NOTES

Tract #1 (Highway Right of Way)


