

ORDINANCE NO. 99-1-1

AN ORDINANCE OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS, PROVIDING FOR THE CONVERSION OF THE CITY OF WESTON FROM A TYPE B GENERAL LAW MUNICIPALITY TO A TYPE A GENERAL LAW MUNICIPALITY, PROVIDING FOR CONFLICTS, SEVERABILITY, FILING AND AN EFFECTIVE DATE.

WHEREAS, the City of Weston is a duly incorporated Type B general law municipality engaged in the provision of city government and related services for the benefit of the citizens of the City of Weston;

WHEREAS, the Weston City Council finds that it is eligible to change to a Type A general law municipality pursuant to Section 6.011 of the Texas Local Government Code; and

WHEREAS, the Weston City Council finds that it is in the best interests of the City and its citizens that the City of Weston change from a Type B general law municipality to a Type A general law municipality.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WESTON, COLLIN COUNTY, TEXAS:

SECTION 1. CHANGE TO A TYPE A GENERAL LAW MUNICIPALITY.

The City of Weston hereby changes from a Type B general law municipality to a Type A general law municipality.

SECTION 2. CONFLICTS.

All ordinances and provisions of the City of Weston, Texas, that are in conflict with this Ordinance shall be and the same are hereby repealed, and all ordinances and provisions of ordinances of said City not so repealed are hereby retained in full force and effect.

SECTION 3. SEVERABILITY.

It is the intent of the City Council that each paragraph, sentence, subdivision, clause, phrase, or section of this Ordinance be deemed severable and, should any such paragraph,

sentence, subdivision, clause, phrase, or section be declared invalid or unconstitutional for any reason, such declaration of invalidity or unconstitutionality shall not be construed to affect the validity of those provisions of this Ordinance left standing.

SECTION 4. FILING.

The Weston City Secretary shall file a certified copy of this ordinance in the official records of the Collin County Clerk.

SECTION 5. EFFECTIVE DATE.

This Ordinance will be effective upon adoption by the Weston City Council.
